1. All matters will be decided on paper unless the Judge or a party require an online hearing in a particular matter. Counsel will not be requested to appear before 14h00. Appearances (if any) will be over Zoom/Microsoft Teams.
2. The draft order, duly signed consent to the draft order by the defendant, and joint submissions/memorandum must be uploaded onto CaseLines.
3. The correct NEXT DATE OF HEARING should be completed in the Caselines Database File.
4. Please check the caselines file for notes from the Judge. If you can rectify the judge's queries before his registrar calls counsel, it will not be necessary to appear.
5. The link to the matter on CaseLines and the draft order in MSWORD format must be emailed to FODEN AJ at robfoden@law.co.za and Simone Bhana at SBhana@judiciary.org.za (16 September 2020) and Thabiso Sibanda TSibanda@judiciary.org.za (18 September 2020) together with the mobile numbers of the counsel appearing for the parties, as well as their email addresses.
