

**SETTLEMENT ROLL BEFORE VAN TONDER AJ**

**FOR 15 SEPTEMBER 2020**

1. All matters will be decided on paper unless the Judge requires an online hearing in a particular matter. The parties must therefore be available.
2. The draft order, consent to the draft order by the defendant and joint submissions/memorandum must be uploaded onto CaseLines, and where applicable a practice note if it is a non-RAF matter.
3. Where a report of a curator ad litem is required it must also be uploaded.
4. In all cases a **duly signed** practice is required to be uploaded/emailed by the Plaintiff confirming the following:
  - 4.1. Details of parties:  
Mobile numbers and email addresses of counsel appearing for the plaintiff.
  - 4.2. Consent to the Draft Order:  
Confirmation that the consent letter/email was obtained from the Road Accident Fund and relates to the draft order presented to the court. In general the joint submissions are not countersigned by the Road Accident Fund to confirm any aspect of the settlement, and the consents obtained are email confirmations or unsigned letters from the Road Accident Fund and confirm a draft order not attached thereto or included therein.
  - 4.3. Joint Submissions/Memorandum/Curator ad Litem reports:  
Without repeating the content thereof, confirmation that the submissions made on behalf of the plaintiff are correct and complete/in respect of a curator ad litem report that the content thereof is correct. The court needs to rely on carefully considered and signed submissions/curator ad litem reports.
  - 4.3 Contingency fee agreements:  
To the extent that it hasn't been covered in the joint submissions/memorandum/Curator ad Litem report, confirmation that a contingency fee agreement hasn't been entered into between the attorney of record and the plaintiff. Where it has been entered into, the contingency fee agreement together with the required affidavits must be provided for consideration. If the contingency fee agreement is invalid it must be stated. The status of the contingency fee agreement must be recorded in the draft order.
5. The draft order in MSWORD format must be emailed to Van Tonder AJ at [hvantonder@lawcircle.co.za](mailto:hvantonder@lawcircle.co.za) and Simone Bhana at [SBhana@judiciary.org.za](mailto:SBhana@judiciary.org.za). Please

include the date of the matter and number on the roll in the subject line and please include the **correct interest rate in the draft order.**

6. In any matter not on CaseLines, where the court file is empty or where the link has not been provided, the link and the documentation in paragraphs 2, 3 and 4 hereinabove must also be emailed to the Judge and his registrar. If a link is not received, the matter will be considered on the emailed documents.
7. It is the plaintiff's responsibility to ensure that the matter is properly before the Court, failing which no order will be granted and it will be removed from the roll if this directive is not complied with by **16:00 on Monday, 14 September 2020.**
