Good morning,

- 1] No virtual videoconference is necessary but practitioners must be available telephonically in the event that the Judge has enquiries.
- 2] All draft orders must be uploaded in word format to caselines together with the consent from the defendant and the necessary memorandum on settlement/joint submissions.
- 3] Any matter in which these documents are not available or a link has not been provided or a link is not properly populated by 24 hours before the date of set down will NOT be heard and the matters will be removed/struck from the roll.
- 4] It is the practitioners duty to ensure that their matter is properly enrolled before Judge Neukircher at least 24 hours prior to date of set down.
