DIRECTIVE

1. Admissions will be done in court at 10h00. Social distancing is to be practised and masks must be worn at all times. Only counsel addressing the court will be allowed to remove his/her mask while addressing the court.
2. Counsel will be expected to confirm in court that the originals of all the submitted documentation were perused by himself/herself, or to hand up an affidavit by the attorney who perused the documentation.
3. Any party who cannot attend physical court is to inform Judge Van der Schyff's registrar by Wednesday 21 April 2021 at 12h00, and provide a full explanation as to why they cannot attend. A virtual platform will be created to tend to virtual admissions at 13h00 on 22 April 2020, if the need arises. number on the roll and surname of the applicant must appear in the subject line of the e-mail.

Where an application for admission will be moved on a virtual platform the attorney acting for the applicant in an application for admission must furnish an affidavit on Caselines that he or she has examined the original documents relating to the identity of the applicant, the degrees conferred on the applicant and verify that they appear to be authentic as well as that the copies thereof attached to the application, appear to be true copies of the originals. The affidavit must preferably be uploaded by Wednesday 21 April 2021 at 12h00. If it is not possible to use Caselines, the affidavit must be e-mailed to stshetlho@judiciary.org.za / selo.tshetlho@webmail.co.za and handed to counsel who will be moving the application. Clearly identify the applicant and the number of the application on the Roll in the subject line of all emails send. Legal representatives are requested to provide the email address of counsel who will be moving the application, and that of the applicant, to stshetlho@judiciary.org.za / selo.tshetlho@webmail.co.za on Wednesday 21 April 2021 by 12h00 so that they may be invited to attend the hearing of the application on Zoom. Applicants must be visible on the Zoom platform when their applications are moved and they must sign the oath that will timeously be e-mailed in a manner that is visible to the judges.
5. Judge Van der Schyff will make notes on caselines' comments section. Counsel are requested to check caselines frequently.
