Draft orders should indicate when the matter will be heard, Judge's name (i.e Kumalo AJ) and the manner in which the matter will be heard (i.e Microsoft Teams, Court name/number (i.e Court 2B) and at the end of the draft order you should indicate name and details of Counsel and those of the instructing Attorney
- e. Court will start with postponements, settlements and removals, matters will then be called according to the roll.
- f. Notice of removals can be emailed to the above email address for matters removed by notice.
- g. Matters that become opposed will be referred to opposed motion court.
