<u>Directive for Judicial Case Management meetings before Pienaar</u> (AJ) for 29, 30, 31 March 2021 and 1st of April 2021

- 1. Parties are referred to paragraph 21 of the Judge President's directive 1 of 2021, as well as paragraph 16 and 32 thereof:
 - 1.1 The effective date of the directive is 18 February 2021.
 - 1.2 Where there is no trial date already allocated and no engagement by parties (such as the RAF), Plaintiffs are instructed to follow the procedures as set out in paragraph 21 and should not have applied for JCM dates.

- 1.3 No readiness certificates will be granted where such applications for a JCM date was made after 18 February 2021 (Subject to the right of the representatives to address the Court as per 1.5 below).
