1. Kindly find the attached Judicial Case Management roll for matter to be dealt with by Acting Judge Msimang from 7 – 11 March 2022. See below MS Teams link for use from 7 – 11 March 2022.
2. Kindly take note that there will be no open court appearances. All matters will be dealt with by way of videoconferencing through Microsoft Teams.
