## DIRECTIVE FOR CIVIL TRIAL INTERLOCUTORY APPLICATIONS BEFORE JUDGE KHUMALO FOR 10 TO 14 OCTOBER 2022

- 1. Attached to this directive is the civil trial interlocutory applications for the week of 10 to 14 October 2022.
- The civil trial interlocutory applications will be called virtually via Microsoft Teams
  daily and the hearing will begin strictly at 10:00. <u>Kindly note that if there is a change
  in the time of the commencement of the hearing, counsel and attorneys will be advised
  of such.</u>
- 3. All counsel are required to appear in all the applications.
- 4. All counsel should be robed for the appearance.
- 5. Only the Counsel/attorney/applicant/respondent for the matter being called before the Judge will be allowed to have their computer's camera and microphone turned on. The rest of the counsel who are not appearing in the called matter will be requested to have their computer's camera turned off and the microphone muted.
