BEFORE STRIJDOM AJ

1. Proceedings will be conducted in **OPEN COURT 4F at 10h:00 am**;
2. Draft orders must correctly depict the Judge's surname (i.e Strijdom AJ), date on which the matter was heard, in which court room and at the end of the draft indicate the name and contact details of the counsel (if any) and instructing attorney;
3. Form 10's must also depict the Judge's surname, date, a space for Judge to affix his signature at the end and be completed in detail. Parties may re-type same in order to include further necessary Information.
4. Counsel must print out **one copy** of the Draft order and Form 10' for each matter;
5. Stamped and signed Draft orders and Form 10's will be uploaded on case lines on the same day unless the court proceedings were delayed and as a result the court adjourned late;

6. A Practice Note, stating the nature of the application, the date, number on the roll and contact details (including email address) of the legal practitioner, must be uploaded on Case lines.
7. During the proceedings the following shall strictly be adhere to:

7.1 Introductions shall take place in chambers, practitioners must report to office number: 2.7 on second floor at 09h:45 am;

7.2 Matters will be called in order of seniority in the following manner:

- 7.2.1. Settlements;
- 7.2.2 Trial Default Judgments;
- 7.2.3 Case Management Conference.

NB Unless there are no Legal Practitioners calling their matters as per above chronological order, Counsels are thus permitted to call their matters in any of the above rolls;

8. Notices of removals which occur before the 05 September 2022 must be emailed to zmsimanga@judiciary.org.za before or on the 01st of September 2022. In which case, Counsel will automatically be excused from Court.
