2. There will be a roll call at 09:45 to allow counsel to indicate matters that are to be stood down should counsel have matters before any senior court;
3. All draft orders in word and pdf format should be uploaded on Caselines. Kindly ensure that it complies with the practice directive, i.e. the Judge's name, date, mode of hearing etc. Including the below disclaimer:

"This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or her Secretary. The date of this Order is deemed to be 09 May 2023.
4. Draft orders must correctly reflect the number on the roll and correct case numbers;
5. Should the Judge direct that an order be amended, parties are to please upload such amended order and title the section as "Final Amended Draft Order" in word and pdf format;
6. An affidavit from the attorney is required stating that they have had sight and perused the

original copies of:

- a. Marriage certificate;
 - b. Ante Nuptial Contract, if any, if the parties were married out of community of property;
 - c. Birth certificates of minor children born from the marriage; and
 - d. Original settlement agreements, with the Family Advocate endorsement should there be provisions relating to any minor children.
7. The court will not deal with matters that were not placed timeously, if your matter was properly enrolled but does not appear on this roll, please contact the enrolment office; and
8. Please allow 5 days for signed court orders to be uploaded.
