DIRECTIVE FOR THE SETTLEMENT COURT ROLL BEFORE SETHUSHA-SHONGWE AJ – 11 MAY 2023

1. Kindly find the attached Settlement Court roll for matters to be dealt with by Sethusha-Shongwe AJ on Thursday, 11 May 2023.
2. Kindly take note that there will be **open court appearances**. The Court will commence at 10h00 at Gauteng Division, Pretoria **Court 4B**. Introductions will be conducted at **Palace of Justice chamber 176, 09h45**.
3. In order for the court to consider the matter, parties should ensure that the all relevant documents, **Practice Note, Notice of Set down** and **Draft Court Order** are **uploaded onto Caselines**. The Draft Court Order should set out the **date of hearing, Roll Number, Judge's name** (i.e Acting Judge Sethusha-Shongwe) and the manner in which the **matter will be heard** (i.e Court 4B), and name and details of Counsel/Practitioner and those of the instructing attorney should appear at the end of the draft.
4. If there is any annexure to the draft court order same should be properly signed and **uploaded on caselines** and also mark the document **Annexure "X1"**.

5. The Counsels/Attorneys moving the application should bring a **copy of the Court Order** and the **Annexure “X1”** similar to the one **uploaded onto Caselines** for the Judge to sign if the Court is satisfied with the application.
6. Attorneys for the Applicant should also ensure that a **compliance declaration** is **uploaded onto Caselines**, failing which the matter will be **removed from the roll**.
7. Kindly take further note that all the relevant documents should be **uploaded onto Caselines** by **Wednesday, 10 May 2023 12h00**. Documents uploaded outside of the stipulated times will not be considered and will result in the **matter being removed from the roll**.
8. The Court roll will be called in **Numerical Order**, Counsel/Practitioners if appearing before a Senior Judge should inform the Judges Registrar for a stand down.
9. The decorum of the court is to be maintained at all times.
10. Notices of removals should be uploaded onto Caselines.
