**MATTERS BEFORE JUDGE NEUKIRCHER**

5. Inform writer hereof as soon as possible of any settlements and withdrawals and please provide a draft order in these terms.
6. A sub-roll indicating exactly when and what time your matter will be heard shall be sent out in due course.
7. Practitioners are to note that the week is a short one with only 4 days available for hearing, thus practitioners will be kept strictly to the duration of matters stated in their practice notes.
8. Practitioners are to provide Judge Neukircher's secretary ([NNair@judiciary.org.za](mailto:NNair@judiciary.org.za)) with a JOINT practice note by no later than **02 August 2021** in which they are to indicate:
  - whether a hearing is necessary or whether the matter may be decided on the papers
  - the agreed duration of the matter where a hearing is required
  - the agreed outline of the disputes
9. In the event that the heads of argument are incomplete or have not been timeously received, or where no practice note has been filed timeously, the matter will be removed from the roll.
