Directive

1. Parties are to inform Mr. Sello Tshetlho without delay if a matter became settled, is to be postponed or removed from the roll.
2. Parties are to ensure that the Notice of Motion and all affidavits with its annexures, and the Notice of Set Down and proof of service (or proof of delivery where applicable) are uploaded to CaseLines by **Friday 12 February 2021**.

3. Parties are to ensure that Joint Practice Notes, and Heads of Argument, are uploaded to CaseLines by **Monday 15 February 2021**.
4. All points *in limine*, points of contention and aspects on which rulings are sought must clearly be set out in the Joint Practice Note (JPN). The JPN must contain all the information as stipulated in the Judge President's Consolidated Directive of 18 September 2020 par 104.
5. In the event that any documents are filed or uploaded out of time, a condonation application must accompany the late filing / uploading of the document. It is the Applicant's responsibility to ensure that the JPN is uploaded and where a respondent does not co-operate this must be stated in the practice note which still needs to be filed timeously.
6. Matters will be heard on a virtual Zoom platform, and the legal representatives', and counsel's email addresses and contact numbers must be provided in the Joint Practice Note.
7. Zoom-invitations will be sent out over the weekend of 19 February 2021 and parties who have not received invitations by Monday 22 February 2021 by 9h00 must telephonically contact Mr Sello Tshetlho at 072 062 4733.
8. Parties are requested to e-mail proposed Draft Orders in Word format to sello.tshetlho@webmail.co.za by 9h00 on the day that a particular matter is heard.
9. Parties must note that members of the public, may observe the virtual proceedings.
10. Counsel must be robed when appearing on the virtual platform. Counsel must mute themselves when they are not arguing but they must be visible at all times when their matter is being heard. Despite the proceedings being conducted virtually, the Court's decorum is to be maintained at all times.
