**BASSON J: 17 JULY 2023 – 21 JULY 2023**

  - 5.3 Nature and brief summary of the motion.
  - 5.4 Relief sought at the hearing by the party on whose behalf counsel is appearing.
  - 5.5 An estimate of the probable duration of the application.
  - 5.6 Number of pages in the application and whether all the papers need to be read and if not, which portion need not be read.

7. Non availability of counsel representing any of the parties will not be allowed as a reason for the matter not to proceed on the allocated date of the hearing.
