1. All the proceedings will be conducted **virtually (MS Teams) commencing at 10:00am. A new link will be emailed to be used on each day. Kindly log in earlier to note your appearances.**
2. Parties should ensure that heads of argument and practice notes are filed on Caselines. Practice notes should set out, amongst others, legal practitioners' contact details (names, email addresses and contact numbers).
3. Parties should ensure compliance with relevant directives pertaining to delivery and uploading of both parties' Heads of Argument or court orders.
4. Parties should upload their proposed **draft orders in word format**. Draft orders should indicate when the matter will be heard, **Judge's name** (i.e Acting Judge Skosana) and **the manner in which the matter will be heard** (i.e Microsoft Teams),

and the end of the draft order should indicate the name and details of Counsel/Practitioner and those of the instructing attorney.

5. Counsel/Practitioners appearing on virtual proceedings should be robed. Counsel/Practitioners not addressing the court should mute themselves but remain visible at all times when their matter is being heard. The decorum of the court is to be maintained at all times.
