**MATTERS BEFORE BOTHA AJ**

1. Kindly note that the matters detailed in the attached opposed motion roll have been allocated to BOTH AJ.
2. Matters will be heard in **open court**. The court in which the matters will be heard will be reflected on the day roll which is circulated on a daily basis.
3. Where matters are to be removed (by agreement) or have become settled, the parties must email Ms Mpuru without delay at [TsMpuru@judiciary.org.za](mailto:TsMpuru@judiciary.org.za). Confirmation that the opposing party agreed to such removal/settlement should be uploaded onto CaseLines.
4. If a party intends to seek a postponement of an application and the opposing party does not consent to such a postponement, a substantial application needs to be served and filed timeously to enable the opposing party to reply thereto.
5. Parties are to provide a **Joint Practice Note** and practitioners should ensure that the joint practice note address all the requirements detailed in

paragraph 154 of the Judge President's Revised Consolidated Directive, 2 of 2022 -

- 5.1. Where the relevant papers are to be found on CaseLines (under which section);
  - 5.2. The agreed duration of the matter;
  - 5.3. The relevant factual chronology;
  - 5.4. Nature of the relief sought;
  - 5.5. Common cause facts;
  - 5.6. The agreed outline of the disputes and issues requiring determination;
  - 5.7. The relevant portions of the papers to be read;
  - 5.8. Whether or not the parties have agreed to forgo an oral hearing, and whether supplementary submissions are expected;
  - 5.9. The particulars and contact details (email and cell phone numbers) of the legal practitioners.
6. The Joint Practice Note in each matter must be uploaded onto CaseLines by **16:00 on 31 May 2023** and must also be emailed to [TsMpuu@judiciary.org.za](mailto:TsMpuu@judiciary.org.za).
  7. Practitioners must ensure that **hard copies of the whole application** is delivered by **16:00 on 31 May 2023** to: G.B Botha, Room 305, New Court Chambers, 115 Paul Kruger St, Pretoria Central, Pretoria, 0001.
  8. In the event that the Heads of Argument and Practice Notes have not been filed and/or timeously received, the matter will be removed from the roll.
