- 6.1. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, consideration of the compliance with the relevant directives pertaining to opposed motions will apply.
- 6.2. Parties should email proposed draft orders in Word format to TsMpuru@judiciary.org.za at least the day before a particular matter will be heard. Such draft orders must also be uploaded on CaseLines. Draft orders should indicate when the matter will be heard, the Judge's name, and the manner in which the matter will be heard (i.e. open court or on a virtual platform), and at the end of the draft order the names and details of all counsel/practitioners and of their instructing attorneys must be included.
