## DIRECTIVE

### OPPOSED MOTIONS BEFORE THE HONOURABLE JUSTICE ELLIS AJ

11 – 13 MARCH 2024

1. The Honourable Justice Ellis AJ will be in the **opposed motion court** during 11 – 13 March 2024. The allocated roll for matters before Ellis AJ is attached hereto for your convenience.
2. Ellis AJ has allocated specific dates and times for hearing the matters.
3. All matters will be heard virtually **via MS Teams**. A MS Teams link will be created for each day and sent to the email addresses of the legal representatives (counsel and attorneys) and or the party appearing in person indicated on the joint practice note.
4. Parties must have ensured that all papers are fully uploaded to CaseLines prior to the set down of the matter. No further uploads of any documents onto CaseLines will be allowed, save for the joint practice note referred to below.
5. The parties are directed to upload a **joint practice note** onto CaseLines no later than 16h00 on **Friday 1 March 2024** containing at least the following:

- 5.1 Names of the parties and the case number.
  - 5.2 Names, telephone numbers and email addresses of all legal representatives (counsel and attorneys) in the matter and if in person appearance, the names, telephone numbers and email addresses of the parties appearing in person.
  - 5.3 Nature and brief summary of the application.
  - 5.4 Relief sought at the hearing by each party.
  - 5.5 An estimate of the probable duration of the application.
  - 5.6 Total number of pages in the application and whether all the papers need to be read and if not, which portion need be read.
  - 5.7 The nature of and basis upon which any documents filed by any party, after set down of the application, should be accepted and permitted by the Court.
6. The parties are further directed to hand deliver hard copies of the documents and or portion of the documents that needs to be read (as stated in the joint practice note), to Circle Chambers 10, Brooklyn Bridge Office Park, 570 Fehrsen Street, Brooklyn, **no later than 16h00 on 4 March 2024.**
  7. Should a matter for any reason not proceed on the given date, the matter may only be removed from the roll or postponed, with leave of the Court.
  8. The parties must prepare oral submissions in line with the allocated time.
  9. Non availability of counsel representing any of the parties, or any party appearing in person, on the allocated date and time will not be allowed as a reason for the matter to be removed from the roll, postponed or not to be heard at all.
