1. Proceedings will be conducted in OPEN COURT 4F during the time & date as per allocations roll attached herein;
2. Draft orders must correctly depict the Judge's name (i.e Holland-Muter AJ), date on which the matter was heard, in which court room and at the end of the draft indicate the name and contact details of the counsel (if any) and instructing attorney;
3. Stamped and signed draft orders will be uploaded on case lines on the same day unless the court proceedings were delayed and as a result the court adjourned late;
4. A Joint Practice Note, stating the nature of the application, the date, number on the roll and contact details (including email address) of the legal practitioner, must be uploaded on Case lines.

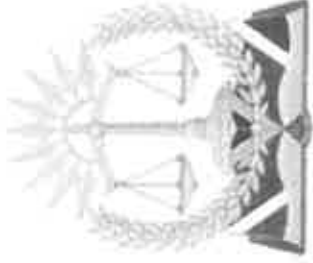
5. During the proceedings the following shall strictly be adhere to:
