Prior to the enrolment of any matter or the allocation of a hearing date, the litigating party or its representative is to upload a **Directive**Compliance declaration in the form of an affidavit which is to confirm that no duplicate file for the matter exists on CaseLines and that all the Parties/their representatives have been invited to the matter on CaseLines. The names of all Parties/their representatives and their telephone numbers and email addresses should reflect on the declaration.

- 6. Parties are to send Draft Orders and Practice Notes in <u>Word format</u> to <u>MDames@judiciary.org.za</u> and <u>mishkadames@gmail.com</u>.
