Kindly take notice of the following in re: JUDGE PRESIDENT'S PRACTICE DIRECTIVE (17 APRIL REVISED DIRECTIVE) read together with JUDGE PRESIDENT'S PRACTICE DIRECTIVE 1 & 2 of 2020:

- 1. The directive shall apply for the rest of Term 2 until 26 June 2020.
