**RE: UNOPPOSED MOTIONS BEFORE MUNZHELELE AJ – 14 & 18 JUNE 2021**

Kindly take note that the following directive will apply in Unopposed Motions before Munzhelele AJ on 14 and 18 June 2021.

1. The motions will be done on papers uploaded on Caselines. However, Counsel must be available in order to answer to the judge's queries should the need arise.
2. Parties are required to ensure that **ALL** relevant documents (including Practice Notes & Notices of Set Down) and pleadings are uploaded onto Caselines.
3. Parties are reminded of para 6 of the Gauteng Consolidated Directive of 18 September 2020 which states the following:

*Prior to the enrolment of any matter or the allocation of a hearing date, the litigating party or its representative is to upload a **Directive Compliance declaration** in the form of an affidavit which is to confirm that no duplicate file for the matter exists on CaseLines and that all the Parties/their representatives have been invited to the matter on CaseLines. The names of all Parties/their representatives and their telephone numbers and email addresses should reflect on the declaration.*

4. Parties are also reminded of the Practice Directive of 18 February 2021.
5. Please ensure that the Judge's name is correctly indicated at the top of the draft order, as well as the date of hearing.
6. All settlements and removals must be promptly brought to the attention of the Judge's Secretary on the contact details provided.
7. Once an order is made, the signed and stamped order will be uploaded to Caselines. Should an order not be on Caselines by close of business on Tuesday, 22 June 2021, parties may send queries to the abovementioned email addresses.
