BEFORE THE HONOURABLE JUDGE OPPERMAN

PLEASE NOTE THAT THE PRESIDING JUDGE HAS DIRECTED AS FOLLOWS:

1. Practice Notes required in terms of paragraph 130 of the Revised – 18 September 2020 Consolidated Directive (*'the Consolidated Directive'*) and Draft Orders, in word format, must be e-mailed to ZTwaku@judiciary.org.za and to ingatwaku@gmail.com by no later than one full court day before the allocated date of the hearing.
2. All legal representatives must be available on the day of the hearing to enable the Judge to make contact about an oral hearing by video conference. Should a legal representative not be contacted/released prior to 10h00 on the allocated date of the hearing, they should appear virtually at 10h00 on the allocated date.
3. All files have been frozen. The reason for freezing the files is to have control over the documents presented for filing after the cut off date. Should a party wish to file further papers before the hearing date, they are to seek the permission of the Judge via her Registrar who will, after the permission is granted, unfreeze the file to permit the uploading of the further documentation. Any party breaching this procedure may, amongst other consequences, be visited with a punitive costs order for such transgression.
4. Legal representatives are to access their Caselines files and are to ensure that a complete set of papers has been uploaded. If the papers are incomplete, the procedure set out in paragraph 3 hereof is to be followed.

5. The Judge may communicate with the parties' representatives via widely shared notes posted on the electronic file. Legal Representatives are to look out for these communications and are requested to respond to such communications.
6. Strict compliance with paragraph 6 of the Consolidated Directive will be demanded.
