Draft orders should indicate when the matter will be heard, Judge's name (i.e Judge Makhoba) and the manner in which the matter will be heard (i.e Microsoft Teams), and the end of the draft order should indicate the name and details of Counsel/Practitioner and those of the instructing attorney.
