1. Kindly find the attached Unopposed Applications for matters to be dealt with by Acting Judge Ndlovane on **Monday 04 July 2022**.
2. Kindly take note that there will be no open court appearances. All matters will be dealt with by way of videoconferencing through Microsoft Teams. The hearing will commence at 10h00 using **Microsoft Teams**.
