**DIRECTIVE:**

**HARD COPY OF PAPERS FILED**

1. The attorney on behalf of the party that enrolled the matter is to ensure that a **hard copy of the full set of indexed and paginated papers (as on Caselines) together with the practice note (and if applicable heads of argument) filed is delivered to the Registrar of Haupt AJ (Office 176, 1<sup>st</sup> Floor Palace of Justice/ alternatively at security at the Palace in the event of Ms Shongwe not being available) as follows:**

**1.1 Matters enrolled for-**

- **13 June 2022: on/before 10h00 on Friday 10 June**
- **15 June 2022: on/before 13h00 on Monday 13 June**
- **17 June 2022: on/before 13h00 on Wednesday 15 June**

- 1.2 The hard copy need not be in a court file but must on the front page indicate the date and number on the roll. Copies may be printed on both sides of the page

- 1.3 **The final enrolment and proof of service of the notice of set down on the respondent must be included. Proof of service of the notice of set down on Respondents in all unopposed divorces is required.**
- 1.4 **The hard copy of the papers will be returned and available for collection from the Registrar of Haupt AJ on 20 June 2022 or such date as arranged with the Registrar.**
2. **All Draft Orders must indicate the date on which the matter was heard, the Judge's name (i.e. Haupt AJ), in which Court and, at the end of the draft order the party must indicate the name, chambers and contact details of their counsel and their instructing attorney.**
3. **A practice note, stating the nature of the application, the date and number on the roll and contact details (including email address) of the legal practitioner, must be filed on Caselines and a hard copy is to be hand delivered to the registrar.**

#### **OPEN COURT HEARINGS**

4. **All hearings shall be conducted in open court as follows except for the matters referred to in 4 hereunder in the following:**
- 4.1 **Rule 43 applications shall be heard from 9h00 to 10h00**
- 4.2 **Unopposed involving minor children or major children who are not yet self-supporting shall be heard from 10h00 together with removals postponements, and draft orders.**
- 4.3 **All other matters shall be heard after the matters referred to in 4.2**
- 4.4 **Summary judgments stand down until the end of the roll.**
- 4.5 **A hard copy (in duplicate) of draft orders must be handed up**
5. **Divorces not involving children as referred to in 4.2 above, shall be decided on the papers filed and no appearance is required**
6. **During the open court hearing the following shall strictly be adhered to:**

6.1 **Masks** to be worn and **social distancing** to be kept amongst counsel appearing. The same applies to individuals/ attorneys sitting in the gallery. Counsel may remove her/his mask when addressing the Court

6.2 Introductions shall take place in court and not in chambers.

6.3 If a counsel is appearing in more than one matter on the roll, counsel is to call all the matters she/he appears in, in order to finalise counsel's roll as expeditiously as possible and for counsel to be excused from the court.
