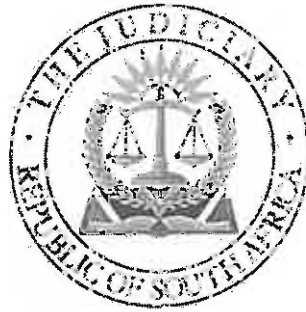

DIRECTIVE FOR UNOPPOSED MOTIONS BEFORE ACTING JUDGE MADIBA ON 2 MARCH 2022

1. Attached to this directive is the unopposed motion roll for 2 March 2022.
2. The unopposed motion roll of Wednesday 2 March 2022 will be called virtually via Microsoft Teams on 2 March 2022 and the hearing will begin strictly at 09:30.
3. All counsel are required to appear in all the applications.
4. All counsel should be robed for the appearance.
5. Only the counsel/attorney/applicant/respondent for the matter being called before the Judge will be allowed to have their computer's camera and microphone turned on. The rest of the counsel who are not appearing in the called matter will be requested to have their computer's camera turned off and the microphone muted.
6. Postponements and removals will be called first. Thereafter the applications will be called in order of seniority. When a counsel takes the platform he/she is allowed to call all the matters in which he/she will be appearing.

7. Please note that after counsel has called all the matters that he or she appears in he or she may leave the platform. It is not necessary to request the Judge to excuse them.
8. Legal representatives should ensure that all relevant documents are uploaded to CaseLines including the practice note, notice of set down and the draft order (in Word format) by Monday 28 February 2022 at 12:00.
9. **The Judge has made a request that a hard copy of the application also be delivered on or before 12:00 on Monday 28 February 2022 to myself, Joanna Hefer, room 8.10, 8th floor, Gauteng Division, Pretoria. It is requested that the draft order also be included in the bundle.**
10. The draft order which is uploaded must clearly reflect the surname of the Judge, date being 2 March 2022, the name of the counsel, the attorney and their respective e-mail addresses. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted.
11. All documents should be uploaded by 12:00 on Monday 28 February 2022. If the documents are not in order, the matter will be removed from the roll. No late documents may be uploaded. If for some reason you are unable to upload the draft order, you may e-mail it to JHefer@judiciary.org.za.
12. Postponements and/or removals should be communicated by e-mail to JHefer@judiciary.org.za.
13. All in person appearances who do not have access to Microsoft Teams are welcome to attend to court 6F and 6G to be assisted by either Ms. Helmien Schoonraad or Ms. Minie Preston. It is advised that as the hearing starts at 09:30 that you attend to court at 08:00.
