

# TO: ALL LEGAL PRACTITIONERS UNOPPOSED MOTIONS DIRECTIVE FOR MONDAY, 28 NOVEMBER 2022, WEDNESDAY, 30 NOVEMBER 2022, AND FRIDAY, 2 DECEMBER 2022 BEFORE KILMARTIN AJ

- Kindly note that <u>all</u> applications will be heard in <u>open court</u> before
  Kilmartin AJ on 28 November 2022, 30 November 2022 and 2
  December 2022 and all counsel are to appear unless their matters are
  settled, removed or postponed timeously in terms of subparagraph 2.5
  below.
- 2. Please note the following:
  - 2.1. To assist the Judge in deliberation of the matters on her roll and to prevent matters from being struck from the roll, parties should ensure compliance with the relevant practice directives pertaining to unopposed motions. Matters where counsel fail to appear will be struck from the roll at the end of the roll.
  - 2.2. Counsel must ensure that, inter alia, the following aspects are addressed in their practice notes (which must be uploaded by close of business on Thursday, 24 November 2022, in respect of matters

enrolled for hearing on Monday, 28 November 2022; close of business on Monday, 28 November 2022, in respect of matters enrolled for hearing on Wednesday, 30 November 2022; and close of business on Wednesday, 30 November 2022, in respect of matters enrolled for hearing on Friday, 2 December 2022):

- the nature of the matter and the relief sought;
- (ii) where pleadings and various applications are uploaded, an indication of which sections must be read;
- (iii) whether the matter was previously postponed and, if so, what the reason was;
- (iv) service, with reference to where the relevant proof of service can be found. If personal service was required and could not be effected, this must be stated; and
- (v) where requirements of a specific Rule or statutory provision must be met, such requirements must be listed and confirmation of where such requirements are dealt with and where proof that they have been complied can be found must be set out.
- 2.3. Save for matters disposed of in terms of subparagraph 2.5 hereof, parties must hand up the proposed draft orders on the day that a particular matter is to be heard. Draft orders should indicate: (i) the number of the matter on the roll; (ii) when the matter will be heard; (iii) the Judge's name (i.e. Kilmartin AJ) and the manner in which the matter will be heard (i.e. in open court); and (iv) at the end of the draft order the names and details of all counsel/practitioners and instructing attorneys should be included. Draft orders must also be uploaded onto CaseLines and be emailed in Word format to TSibanda@judiciary.org.za.

2.4. Notices confirming that matters are to be removed, postponed or

have been settled, must be emailed to TSibanda@judiciary.org.za

and uploaded on CaseLines. If this is done by close of business

the day before the hearing, counsel will be excused from court.

3. Other than the notices referred to in paragraph 2.3, no documents may

be uploaded on CaseLines after the roll has closed.
