**DIRECTIVE:**

1. There will be roll call on Tuesday, 18 April 2023 in open court \_\_\_\_ at 10h00. All parties are urged to check the day roll to confirm the court that is allocated.
2. Matters which were not properly enrolled and/or ready at the close of the roll, that is on Thursday, 13 April 2023, will be struck from the roll, with exception of application brought outside of ordinary court hours.
3. The contact number for urgent applications to be heard out of ordinary court hours is 068 104 7107. The number is NOT to be used for general queries or for any issues other than urgent applications to be heard out of ordinary court hours. The phone will only be answered after normal court hours.
4. Should any party in any matter experience any problems, you're urged to communicate same to the Judges Secretary timeously.
5. In all applications a Practice Note must be filed setting out the following:
  - 5.1 grounds of urgency;
  - 5.2 Nature of relief sought;
  - 5.3 Total number of pages;

- 5.4 An indication of which portion of the papers must be read;
- 5.5 The estimate duration of the matter; and
- 5.6 The contact details of the legal practitioners, which must include both mobile number and email addresses.
6. Matters will be struck for want of a Practice Note, unless there is a good cause or exceptional circumstances.
7. Due to time constraints imposed due to the nature of urgent court proceedings, no consideration will be given to documents belatedly filed, save in exceptional circumstances. A satisfactory explanation must be incorporated in the Practice Note.
8. Parties should ensure that all the necessary papers are uploaded onto Caselines by no later than Sunday, 16 April 2023 at 12h00.
9. Save with the leave of the Judge, no further documents, with the exception of the Heads of Argument, may be uploaded after Sunday, 16 April 2023 at 12h00.
10. In all opposed applications, the Heads of Arguments of the Applicant must be uploaded by no later than 14h00 on Sunday 16 April 2023 and the Respondents to file no later than Monday, 17 April 2023 at 10h00.
11. Please inform the Judge's Secretary of any settlement or removals immediately.
12. There will be no introductions. Inductions will be done in court.
