2. In the interim and to assist the above-mentioned Judge, please note the following:

- 2.1. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives pertaining to unopposed motions.
- 2.2. Save for matters disposed of in terms of subparagraph 2.3 hereof, **parties must hand up the proposed draft orders on the day that a particular matter is to be heard.** Draft orders should indicate when the matter will be heard, the Judge's name (i.e., Madam Justice Kubushi) and the manner in which the matter will be heard (i.e., in open court), and at the end of the draft order the party must indicate the name and details of both counsel / practitioner and that of their instructing attorneys.
