## DIRECTIVE FOR THE UNOPPOSED APPLICATIONS ROLL BEFORE KHWINANA AJ - 08 MARCH 2023

- 1. Kindly find the attached Unopposed Applications for matters to be dealt with by Khwinana AJ on Wednesday, 08 March 2023.
- 2. Kindly take note that there will be **open court appearances**. The Court will commence at 10h00 at Gauteng Division, Pretoria **Court 4D**. Introductions will be conducted at **Palace of Justice chamber 176, 09h40**.
- 3. In order for the court to consider the matter, parties should ensure that the all relevant documents, **Practice Note**, **Notice of Set down** and **Draft Court Order** are **uploaded onto Caselines**.
