**DIRECTIVE FOR UNOPPOSED MOTIONS BEFORE NOKO AJ**

**13, 15 AND 17 MARCH 2023**

1. Kindly take note that matters will be dealt with in open court commencing at 10:00 each day. Please verify the court venue on the day roll.
2. Legal Practitioners are required to appear in all the applications.
3. Postponements and removals will be called first. Thereafter matters will be called in order of seniority and once the Legal Practitioner is on his/her feet, he/she may call all matters on the roll in which he/she is appearing.

4. Legal practitioners need not introduce themselves in chambers, they can just stand up in court and introduce themselves.
5. Legal representatives should ensure that all relevant documents are uploaded to CaseLines/Court Online including the practice note, notice of set down and the draft order (in Word format) by 16:00 two court days prior to the hearing of the matter i.e. for matters enrolled for 13 March 2023 to be uploaded by 16:00 on Thursday 9 March 2023, matters enrolled for 15 March 2023 to be uploaded by 16:00 on Monday 13 March 2023 and matters enrolled for 17 March 2023 to be uploaded by 16:00 on Wednesday 15 March 2023.
6. A draft order in Word format, reflecting the Judge's surname, the relevant date and the correct case particulars should be uploaded as per the timeline described in paragraph 5 above.
