**VIRTUAL HEARINGS**

1. All hearings will be conducted **virtually via MS TEAMS** (the link will be shared in the notes section of each matter on Caselines). Proceedings will commence at **10h00**.
2. Parties are to join the virtual meeting at least 15 minutes prior to the commencement of proceedings. Cameras must be turned off and microphones muted unless making submissions. Parties must refrain from sitting near windows as the light may be distracting on the video feed.
3. Parties must ensure that Draft Orders are uploaded onto Caselines and emailed to Mrs. C Msimango on [ChMsimango@judiciary.org.za](mailto:ChMsimango@judiciary.org.za) in **WORD FORMAT** a day preceding the date of hearing.
