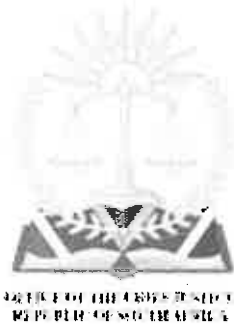
- 1. Kindly be advised that there will be no court appearance. All matters are to be decided on paper unless indicated otherwise.**
