

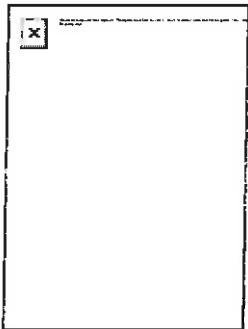

**OPEN COURT HEARINGS**

1. All hearings will be conducted in **open Court 6E** from **10h00**.
2. **Parties must bring hard copies of Draft Orders sought.**
3. **Draft Orders** must correctly indicate the Judge's name (i.e. Ndlovane AJ), date on which the matter was heard, in which Court and at the bottom of the draft order the party(ies) must indicate the name and contact details of their counsel and their instructing attorney.
4. **A practice note**, stating the nature of the application, the date and number on the roll and contact details (including email address) of the legal practitioner, must be filed on Caselines.
5. During the open court hearing the following shall strictly be adhered to:

- 5.1. Introductions shall take place in court and not in chambers.
- 5.2. If a counsel is appearing in more than one matter on the roll, counsel is to call all the matters she/he appears in, in order to finalise counsel's roll as expeditiously as possible and for counsel to be excused from the court.
