1. Please be advised that it is not protocol to contact a Judge personally, either by way of an email, phone call or by way of notes on CaseLines, unless you want to remove or postpone your matter
2. All matters relating to the urgent roll will be done virtually via Microsoft Teams. The link will be sent to all via email. Should you be on the "roll call" roll on Tuesday 17 August 2021 kindly join the Microsoft Teams at 10:00, if your matter is allocated to a specific time and date you need not join the roll call at 10:00 on Tuesday 17 August 2021, but should be available on the date allocated to you.
3. Kindly note that if a matter is of such urgency that you cannot comply with the practice directives you will have to fully explain in a practice note why condonation should be granted, in the absence of such a practice note your matter will not be attended to.
4. Further please note that your practice note is essential and must comply with ALL the Practice Directives issued by the Judge President pertaining to the urgent court. If not, please rectify and upload it onto CaseLines before 13:00 tomorrow (FRIDAY 13 AUGUST 2021). **IF THIS IS NOT DONE YOUR MATTER WILL BE STRUCK FROM THE ROLL.**
5. Please also note that the master bundle must be properly indexed and paginated and uploaded onto CaseLines. Each document must be individually identified in the master bundle, including annexures. If not, it will result in your matter being struck from the roll. This must be done before 13:00 TOMORROW (Friday 14 August 2021).

6. Kindly also note not to contact the judge's registrar on their personal phone but on the urgent court phone no **068 104 7107**. This number is only to be used after hours (16:00 in the afternoon to 08:00 in the morning) and over weekends.
