DIRECTIVE

- Matters will be heard in open court, unless otherwise arranged in exceptional circumstances. Counsel and parties are requested not to remove their masks unless addressing the Court. Social distancing should be adhered to at all times.
- 2. Applicants should ensure that all CaseLine's files contain a proper Index.
- 3. A Directive Compliance affidavit needs to be filed in each matter.
- 4. Comprehensive Heads of Argument and a Practice Note are to be filed in each matter by Monday 2 August 2021 at 12h00. Failure to file will be an indication that there is no appearance for the parties concerned and the application may either be struck off the roll or be dealt with in the absence of such party.

- 5. The <u>Practice Note</u> must indicate at least the following (to assist the senior Judge to consider the matter, to do the allocations timeously and for both judges to be used in their preparation):
 - 5.1 Particulars and contact details of the legal practitioners;
 - 5.2 Nature of the relief sought (without referring to the notice of motion):
 - 5.3 Total number of pages:
 - 5.4 A brief summary of the factual as well as legal issues involved;
 - 5.5 A clear indication (without referring to the heads of argument) which portion of the papers must be read and which not;
 - 5.6 The main issues to be considered;
 - 5.7 A brief summary of the urgency or absence thereof;
 - 5.8 Whether there was **service by the sheriff**, and if not, why not (unopposed applications), and where in the court papers the Sheriff's return can be found;
 - 5.9 Estimated duration.
- The applicant must also set out the reasons, in the Heads of Argument, why the matter is so urgent that it must be heard during the week concerned, by referring to the evidence in the founding affidavit.
- 7. All papers should have been fully uploaded by 12h00 Thursday 29 July 2021. If an application has not been filed, i.e. fully uploaded, by 12:00 on Thursday 29 July 2021 (when the roll closed, and subject to the degrees of urgency), the application may not be heard and may be struck off the roll (Practice Manual, Annexure "A" to 13.24, par [4], sub-par 3, p H2-139). Papers which have not been properly indexed and paginated also run the risk of being struck off the roll. No late filing of papers will be condoned in the absence of a substantive condonation application, which application will be considered on merit.
- 8. The Practice Directive regarding Urgent Applications (Chapter 13.24 of the Practice Manual) will still apply (to opposed and unopposed applications) and the Rules pertaining to urgency will be strictly enforced. Compliance with annexure "A" (13.24), more particularly par [4], subparagraphs (1) to (11) thereof, as

referred to in paragraph 11 of Chapter 13.24 of the Practice Manual, will also be strictly enforced. If a matter is not ready to be adjudicated on the date and the time indicated in the notice of motion (subject to the degrees of urgency) and/or not to be so urgent as indicated in the Rules and the Practice Directive, it may be struck off the roll in which event a punitive costs order, as indicated in paragraph 181 of the Judge President's Directive dated 11 June 2021, may be made.
