- 1. All matters will be heard via MICROSOFT TEAMS.
- 2. The link will be sent to the Bar Associations for the attention of the Legal Practitioners (LPs).
- 3. Papers are to be properly indexed and paginated with a Practice Note in line with the latest Practice Directive, dated 11 June 2021. <u>If this is not done your matter will be</u> struck from the roll.
- 4. No piece-meal filing of affidavits will be allowed.
- 5. The Caselines bundle will be frozen by 11h00 on 03 June 2022 and no further documents will be filed without the Judge's specific written permission.
