- [1] If cases were not ready at time of filing at 12:00 on Thursday, 29 September 2022 (i.e. all relevant affidavits filed and the cases indexed and paginated), they will not be heard, unless there is good cause or exceptional circumstances.
- [2] All cases MUST be uploaded onto Caselines and all necessary documents must be uploaded timeously in each matter. If any problems are experienced, the judge's registrar may be contacted. In the absence thereof, where no link has been received or the matter cannot be found on Caselines, the matter will be struck from the roll.
- [3] A practice note must be filed on Caselines setting out the following:
 - (a) The grounds for urgency;
 - (b) The nature of the application;
 - (c) The estimated duration of the matter;
 - (d) If there is non-compliance with the JP's directives issued for the lockdown period or the practice directives for urgent court, the reasons for such deviation;
 - (e) Contact details for the legal practitioners, which must include both cell phone numbers and email addresses;

- (f) Whether the matter can be decided on the papers or whether a video conference is required.
- [4] Where no certificate of urgency has been filed and/or no practice note has been filed the matter will be struck from the roll unless good cause is shown for non-compliance as per the issued directive.
- [5] Please also note that the master bundle must be properly indexed and paginated and uploaded onto CaseLines. Each document must be individually identified in the master bundle, including annexures. If not, it will result in your matter being struck from the roll. This must be attended to before 16:00 on Friday, 30 September 2022.
- [6] No piece-meal filing of affidavits will be allowed after 16:00 on Friday, 30 September 2022, unless permission is sought from the presiding judge, please call Suzette Naude on 083 469 9997.
- [7] In all opposed matters, heads of argument are to be filed by both parties before 16h00 on Friday, 30 September 2022. Strict regard will be had to the rules of urgency.
- [8] If there is non-compliance with the practice directive, the matter will be struck from the roll, unless good cause is shown for non-compliance.
- [9] There will be a roll-call on Tuesday, 4 October 2022 and matters not so urgent and opposed will be spreaded out to Wednesday and even Thursday. <u>Physical court</u> <u>hearings</u> will start at 10:00 every day unless specifically otherwise stated.
- [10] An allocation does NOT mean that the matter is considered sufficiently urgent to be heard on the merits. Submissions will need to be made regarding the grounds of urgency.
