(09-13 OCTOBER 2023)

### **BEFORE THE HONOURABLE JUSTICE KUMALO J**

- 1. Please be advised that there will be a roll call for all urgent matters before Kumalo J. The roll call will be conducted on Tuesday, 10 October 2023 in **open court, Court 4B at 10h00**.
- All applications must be properly issued by the Registrar seated at the General Office in the High Court Building, with the exception of applications brought outside of the ordinary court hours, before the secretary to Judge Molopa-Sethosa (as the senior judge) is approached for the enrolment of applications.
- The contact number for urgent applications to be heard out of ordinary court hours is 068 104 7107. The number is <u>not to be used for general enquiries</u> or for any issue other than urgent applications to be heard out of ordinary court hours. The phone will only be answered after normal court hours.
- Communication relating to matters before Judge Kumalo may be directed to Ms Nobuntu Mbatha via email at <u>NoMbatha@judiciary.org.za</u>, or telephonically on 012 492 6900 or physically in office 235, 2<sup>nd</sup> Floor at the Palace of Justice; and
- 5. All court bundles are to be fully uploaded onto Caselines. If any problems are experienced the judge's secretary must be contacted TIMEOUSLY. It is the duty of the applicant's attorney to ensure that there are no duplicate cases created on Caselines.
- 6. Applications heard out of the ordinary court hours will be heard via Microsoft Teams at a time indicated by the respective Judge.
- 7. Due to the time constraints imposed by the nature of the urgent court, no consideration will be given to documents belatedly filed, save in exceptional circumstances. A satisfactory explanation must be incorporated in the practice note.

- 8. Parties must ensure that all papers necessary for the urgent hearing are uploaded by no later than Sunday, 08 October 2023 at 12h00.
- 9. In all applications a Practice Note must be filed setting out the following:
  - a. The grounds of urgency;
  - b.Nature of relief sought;
  - c. Total number of pages;
  - d.An indication which portion of the papers must be read;
  - e. The estimate duration of the matter; and
  - f. Contact details for the legal practitioners, which much include both cellphone numbers and email addresses.
- 10. A matter will be struck from the roll where parties have failed to file a Practice Note, unless there is good cause or exceptional circumstances.
- 11. Parties must prepare hard copy draft orders to be handed up when matters are called.
- 12. Save with the leave of the Judge, no documents (save for heads of argument) may be

uploaded after 12h00 on Sunday 08 October 2023.

13. In all opposed applications, heads of argument of Applicant parties in each matter must be

uploaded by no later than 14h00 on Sunday 08 October 2023 and Respondents to file no

later than Monday, 09 October 2023 at 10h00.

- 14. Practitioners are reminded of the normal Rules and practice pertaining to the bringing of urgent court applications and are urged to take note of the Memorandum to Practitioners *in re*: Procedure in the Pretoria Urgent Motion Court.
- 15. Service of process in all urgent applications shall comply with the Rules of Court. Where an agreement was reached by all the representatives of all parties to vary the requirements of the Rules to facilitate a wholly electronic exchange of papers, this must be specifically stated in the practice note.
