- 1. If cases were not ready at time when the roll closed at 12:00 on Thursday 08 June 2023 (i.e. all relevant affidavits filed and the case indexed and paginated) and where no link has been received, the matter will be struck from the roll, they will not be heard, unless there is good cause or exceptional circumstances..
- 2. All cases MUST be uploaded on either Caseline or Court on line. However these matters can only be accessed by the Judge on Caseline and therefore all necessary documents must be uploaded on that platform (as a temporary measure). If any problems are experienced, the judge's registrar must be contacted TIMEOUSLY.
- 3. A practice note must be filed setting out the following:

- 4. Where **no certificate of urgency** has been filed and/or **no practice note** has been filed the matter will be struck from the roll unless good cause is shown for non-compliance as per the issued directive.

Virtual court hearings will start that Tuesday at 10h00 in accordance with allocation roll that will be sent to the practitioners in due course. Legal practitioners are urged to log on to the MS Teams virtual hearings at least 15 min before the timeslots indicated on the allocation roll.
